- The head coach must have a minimum qualification of Level II, First Aid, Safe Guarding, CRB/DBS and be registered with Volleyball England.
- The period of appointment shall be for 2 years with an annual review

MAIN DUTIES

1. To take full responsibility for the SWVA Inter Regional Championships squad coaching sessions.
2. All sessions are run as part of the SW Junior VC, to keep an up to date database of players, assistants and volunteers who attend any coaching session (Required for Insurance).
3. Assist the team manager to ensure that all players have registered with the SWVA on line sign in form and have provided a SWVA parent consent (to be held by the manager).
4. To prepare a programme of coaching sessions and maintain the squad information on the SWVA web site, including all calendar entries.
5. To perform a risk assessment of the venue before each training sessions.
6. To work with the assistant coaches, team manager and take personal interest in their development in these roles.
7. To encourage active participation of other coaches, clubs, school, county etc, in regional training sessions.
8. To attend the SWVA Committee meetings.
9. To offer feedback and to provide a written report and squad photos to the SW Regional Committee on the degree of success of squad coaching and competitions.
10. To recruit and select players for the SWVA IRC squad.
11. To travel to competitions with the junior squad(s).
12. To inform the Regional JDO and the team manager in advance of any sessions you cannot attend.

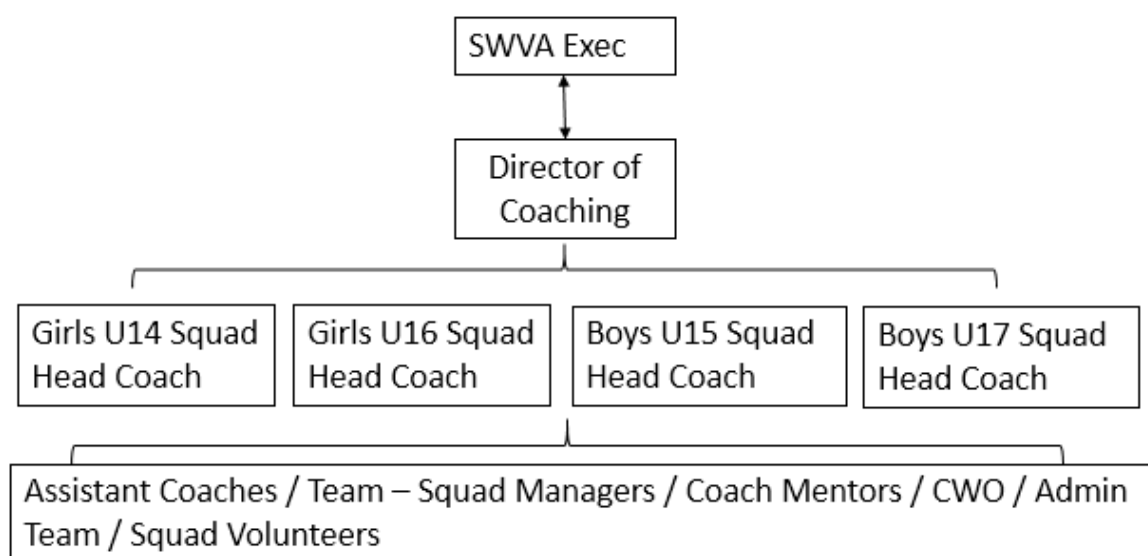

13. To ensure the training sessions abide by the VE Codes of Conduct relating to young players and that the staff and volunteers work within the guidelines laid down by the VE Child Protection policy.
14. To maintain a detailed record of expenses incurred in performance of regional duties.
